RULES AND REMINDERS

- 1) Vendors will be open to the public from 12:00 noon until ??? on Friday, April 20, 2012 On Saturday, April 21, 2012, vendors will be open from 9:00 a.m. until ??? Set up time is **9:00 a.m. until noon on Friday, April 20. VENDORS WHO OPERATE OUT OF A TRAILER WILL BE GIVEN SPECIFIC TIMES FOR SET UP, AND WILL NOT BE ALLOWED TO PULL IN AND SET UP PRIOR TO THAT TIME, PLEASE DO NOT ASK.**
- 2) Vendors operating out of self-contained trailers and plan to set up a separate gazebo/tent outside of the trailer to accommodate customers or to display merchandise will be charges an additional \$40 for each 10x10 space used or **YOU WILL BE ASKED TO REMOVE THE TENT.**
- 3) All items must be priced. The StarDaze Festival Committee asks that exhibitors not cut prices during the duration of the festival.
- 4) Entire display and chairs must be kept within your booth. **YOU ARE RESPONSIBLE FOR PROVIDING YOUR OWN TABLES, CHAIRS, AND EXTENSION CORDS.**
- 5) **NO VEHICLES CAN BE PARKED IN THE VENDOR AREA. Vendors are asked to unload their items as quickly as possible, remove their vehicle from the exhibit area, then come back and set up their booth.**
- 6) Police security will be provided over night, Friday, April 20th.
- 7) The StarDaze Festival will be held on the lawn of the Lincoln County Courthouse. It is located in downtown Star City, Arkansas, on Hwy 425.
